AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE SOUTH HAY HOLLOW ROAD LATERAL; PALM STREET LATERAL AND FISH HATCHERY ROAD LATERAL. WARDS 2, 7 & 9, DISTRICTS 2, 7 & 12

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add South Hay Hollow Road Lateral # D02FW08003, located south from South Hay Hollow Road, Ward 2, District 2; and
2. Add Palm Street Lateral # D09JW01067, located south from Palm Street, Ward 9, District 12; and
3. Add Fish Hatchery Road Lateral # D07AW03001, located north of 65180 Fish Hatchery Road, Ward 7, District 7.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
