ORDINANCE AUTHORIZING THE PARISH PRESIDENT TO PROCEED WITH AN EXPROPRIATION AND ACQUISITION OF THE ASSETS OF SOUTHEASTERN LOUISIANA WATER & SEWER CO., L.L.C.

WHEREAS, St. Tammany Parish is authorized to expropriate or otherwise acquire private property for public purposes, including the assets of Southeastern Louisiana Water & Sewer Co., L.L.C., all in accordance with the provisions set forth in R.S. 19:2, et seq., R.S. 33:4621, et seq., and all other applicable authority; and

WHEREAS, it is in the best interest of the public's health, safety and welfare to acquire the assets of Southeastern Louisiana Water & Sewer Co., L.L.C. for the purpose of having a public entity provide central water and sewer service to the residents of St. Tammany Parish.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that the Parish President is authorized to proceed with an expropriation or acquisition of the assets of Southeastern Louisiana Water & Sewer Co., L.L.C. and, to the extent necessary to facilitate and accomplish said acquisition, to coordinate and cooperate with any federal, state or local political subdivision, agency or department.

REPEAL: This Ordinance shall supercede all Ordinances or parts of Ordinances that are in conflict herewith.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinances are hereby declared to be severable.

DATE OF ENACTMENT: This Ordinance shall become effective fifteen (15) days after adoption.
