AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE HELTEMES LANE LATERAL, FRANCIS STREET LATERAL AND AN EXTENSION OF HILLCREST BLVD. LATERAL. WARDS 6 & 7, DISTRICTS 6 & 7

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Heltemes Lane Lateral # D07EW02038, located south off Heltemes Lane, Ward 7, District 7
2. Add Francis Street Lateral #D06OW01006, located off Francis Street, Ward 6, District 6
3. Add approximately 270 feet to the length of Hillcrest Blvd. Lateral # D06OW05041, Ward 6, District 6

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
