RESOLUTION APPROVING AND AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO SIGN AND/OR EXECUTE INTERGOVERNMENTAL AGREEMENT BETWEEN THE PARISH OF ST. TAMMANY AND THE CITY OF MANDEVILLE IN ORDER TO IMPLEMENT WASTEWATER MANAGEMENT PLAN.

WHEREAS, the Parish and the City are authorized, pursuant to the provisions of Subpart A, Part VII, Chapter 2, Title 33 of LA R.S. 33:1321-1337, to enter into an Intergovernmental Agreement for the purpose of developing a wastewater management plan; and

WHEREAS, in August 2000 the Regional Planning Commission (RPC) requested a study to evaluate the existing sewerage infrastructure in St. Tammany Parish and to develop a wastewater management plan. Included in this plan is regional wastewater treatment projects located in the unincorporated areas around the municipalities of Mandeville and Slidell; and

WHEREAS, included in the wastewater management plan is cooperation with the cities of Slidell and Mandeville for, among other goals, bulk wastewater treatment by the municipalities for the unincorporated areas; and

WHEREAS, St. Tammany Parish has and/or will secure \$150 Million in project funds from the State Revolving Loan Fund, \$7.6 Million from the Louisiana Recovery Authority and \$4 Million from the Coastal Impact Assistance Program to initiate and complete both the Mandeville and Slidell area regional wastewater treatment projects referred to herein; and

WHEREAS, it is the desire of the St. Tammany Parish Government to enter into an Intergovernmental Agreement by and between the Parish and the City of Mandeville regarding the parties' obligations in facilitating the goals of the regional wastewater management plan.

THE PARISH OF ST. TAMMANY HEREBY resolves that the Parish President is hereby authorized to sign and/or execute an Intergovernmental Agreement between St. Tammany Parish and the City of Mandeville and to take any and all actions necessary, including entering into all agreements or negotiations in furtherance of the actions authorized herein; and

That all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.
