AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE BROWNSWITCH ROAD; JEFFERSON AVENUE; AND MORGAN ROAD LATERAL DITCH. WARDS 1, 3 & 8, DISTRICTS 1, 5 & 9

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Brownsitch Road, located approximately. 5,900 feet from US Hwy. 11, Ward 8, District 9; and
2. Add Jefferson Avenue, located off 2nd and 3rd Streets, Ward 3, District 5; and
3. Add Morgan Road Lateral, located off Morgan Road (R01B003) for approximately 300 feet, Ward 1, District 1

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
