RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO SIGN AN AMENDMENT TO COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE STATE OF LOUISIANA, DIVISION OF ADMINISTRATION TO INCREASE ST TAMMANY PARISH'S ALLOTMENT OF DISASTER RECOVERY FUNDS FOR THE PURPOSE OF IMPLEMENTING THE ST. TAMMANY PARISH LONG TERM COMMUNITY RECOVERY PLANS AS APPROVED ON AUGUST 17, 2007 BY THE LOUISIANA RECOVERY AUTHORITY

WHEREAS, on August 17, 2007 the Louisiana Recovery Authority adopted the Long Term Community Recovery Program - Action Plan Amendment Number 12 for Disaster Recovery Funds calling upon certain parishes to develop their own plan to for distribution of CDBG funds made available for Long Term Recovery projects

WHEREAS, the Louisiana Recovery Authority and the State of Louisiana identified an initial total allocation of \$200,000,000 for long term recovery projects to be identified by the receiving parishes as identified within a Long Term Recovery Plan and further designated that St. Tammany Parish would receive \$ 6,232,665 of the initial allocation.

WHEREAS, the Louisiana Recovery Authority required as part of qualifying for this allocation, the adoption of the Plan including projects to be funded by the initial allocation and additional recovery projects that could be considered for funding in the future.

WHEREAS, St Tammany Parish Government has developed this Long Term Recovery Plan utilizing the information and priorities as outlined in the ESF-14 Long Term Planning Process, the New Directions 2025 Comprehensive Planning Process and the 10 Year Infrastructure Planning Process. Each of these programs having extensive public input prior to adoption.

WHEREAS, a second allocation of \$19,158,505 will bring the total allocation to \$25,391,170.00 for the purposes of implementing the St. Tammany Parish Long Term Recovery Plan and that allocation must be formally accepted by the St. Tammany Parish Government.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES and the Parish president to sign an amendment to the Cooperative Endeavor Agreement between the State of Louisiana, Division of Administration, Office of Community Development to increase the St. Tammany Parish's allotment of Disaster Recovery Funds for the purpose of implementing the St. Tammany Parish Long Term Community Recovery Plans as approved on August 17, 2007 by the Louisiana Recovery Authority.
