AN ORDINANCE ESTABLISHING A SPEED LIMIT OF 35 MPH ON FAIRHAVEN ROAD (2-U-2). (WARD 2, DISTRICT 2)

Whereas, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the parish; and

Whereas, affected residents have requested that the speed limit be increased.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, in regular session convened that:

SECTION I: A speed limit of 35 mph is hereby established on Fairhaven Road (2-U-2), Ward 2, District 2.

SECTION II: The Parish Department of Public Works is directed to replace the existing 25 mph signs with 35 mph signs.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This ordinance shall become effective immediately upon final adoption.
