WHEREAS, it is necessary to further extend the moratorium to allow sufficient time to evaluate and formulate measures to protect residents of the area more fully described within this ordinance.

TAMMANY HEREBY ORDAINS that it extends for an additional six (6) months the moratorium on the receipt of submissions by the Parish Zoning and Planning Commissions for the rezoning or resubdivision of property west of Highway 11 and south of Interstate 12 within unincorporated boundaries of Ward 9, Council District 14.	
BE IT FURTHER ORDAINED that this Ordinance shall become effective upon final adoption and remain in effect through November 6, 2009.	
BE IT FURTHER ORDAINED that the moratorium imposed may be vacated, in whole or in part, by Resolution of this governing body pursuant to Chapter 5, Article II, Section 5-056.00 of the Parish Code of Ordinances.
