AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE FRANK BLACKWELL ROAD LATERAL; DOUBLOON BAYOU LATERAL; AND MARIGOLD DRIVE LATERAL. WARDS 1, 6 & 8, DISTRICTS 1, 6 & 13

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Frank Blackwell Road Lateral # D06HW01051, located west off Frank Blackwell Road, Ward 6, District 6;
2. Add Doubloon Bayou Lateral # D08PW01010, located north of Middle Pearl Drive, Ward 8, District 13; and
3. Add Marigold Drive Lateral # D01DW01012, located off Marigold Drive, Ward 1, District 1.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
