ORDINANCE TO CLOSE A PORTION OF K WEST STREET FOR  
AN INDEFINITE PERIOD OF TIME, LOCATED IN  
ALEXIUSVILLE SUBDIVISION, WARD 3, DISTRICT 5.

WHEREAS, petitioners, who owns property abutting K West Street, south of Covington, have petitioned the St. Tammany Parish Council to close a portion of K West Street at its intersection with Harrison Avenue in Alexiusville Subdivision; and

WHEREAS, the petitioners are petitioning the Council to close K West Street at its intersection with Harrison Avenue for an indefinite period of time, and are further requesting the Parish to construct a barricade at said intersection to prevent vehicles from entering or leaving K West Street at said intersection; and

WHEREAS, the request is made in the interest of public safety and general welfare because the intersection will become dangerous upon completion of construction of the new Falconer Drive Extension which will intersect with Harrison Avenue; and K West Street is currently being used by high volumes of traffic as a cut-through street between Harrison Avenue and 9<sup>th</sup> Avenue; and

WHEREAS, the Departments of Public Works, Engineering, and Planning have reviewed and researched said request and have reported their findings to the St. Tammany Parish Planning Commission; and

WHEREAS, the St. Tammany Parish Planning Commission, upon review of the petition, and after having considered all of the facts relevant to this request, has concluded that the request to close a portion of the street for an indefinite period of time is justified, and therefore recommends to the Parish Council the adoption of the proposed street closure.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that the Parish Council concurs with the findings of the Planning Commission and therefore grants approval of the street closure for a portion of K West Street at its intersection with Harrison Avenue subject to the following:

1. The street closure shall occur on K West Street at its intersection with Harrison Avenue approximately at the northern most end of the K West Street Right-of-Way.
2. The portion of street shall be closed for an indefinite period of time and can be reconsidered for reopening at any time hereafter at the request of either the petitioners or any other property owner in interest.
3. A barricade will be constructed and maintained by the Parish Department of Public Works after consultation with the Department of Engineering..

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby and henceforth repealed.

**Administrative Comment**

**Off the Floor Item # 4**

**June 4, 2009**

**This ordinance is time sensitive in nature and should be introduced off the floor.
