ORDINANCE AUTHORIZING THE PARISH PRESIDENT TO EXECUTE COOPERATIVE ENDEAVOR AGREEMENT BY AND BETWEEN ST. TAMMANY PARISH RECREATIONAL DISTRICT NO. 7 AND THE PARISH OF ST. TAMMANY FOR THE PLACEMENT AND CONSTRUCTION OF A PAVILION AT LOCK #1. WARD 6, DISTRICT 6.

WHEREAS, the Board of St. Tammany Parish Recreation District No. 7 desires to construct a pavilion on parish property located in the vicinity of the Lock #1 Boat Launch on the Pearl River Canal near the end of Lock #1 Road; and

WHEREAS, to assist St. Tammany Parish Recreation District No. 7 in providing recreational amenities to the residents of St. Tammany Parish, it being in the best interest of the public health, safety and welfare to provide such recreational amenities, the Parish proposes to enter into a cooperative endeavor agreement with Recreation District No. 7 for the purpose of allowing the Recreation District to construct the pavilion on Parish property located at Lock #1.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, in regular session convened that the Parish President is authorized to enter into a Cooperative Endeavor Agreement with St. Tammany Parish Recreation District No. 7 for the purpose of allowing St. Tammany Parish Recreation District No. 7 to construct a pavilion on Parish property located at Lock #1.

REPEAL: All Resolutions, Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
