TAMMANY PARISH COUNCIL, in a public hearing held on September 3, 2009, which hearing was conducted in accordance with the open meetings law and the additional requirements of Article VII, Section 23(C) of the Constitution, that the following millage rate(s) be and they are hereby levied upon the dollar of the assessed valuation of all property subject to ad valorem taxation within St. Tammany Parish for the year 2009, for the purpose of raising revenue:
