A RESOLUTION AUTHORIZING ST. TAMMANY PARISH GOVERNMENT TO ADMINISTER GRANTS APPROPRIATED TO ST. TAMMANY PARISH COUNCIL IN ACT 122 OF THE LOUISIANA 2009 REGULAR SESSION OF THE LEGISLATURE.

WHEREAS, Act 122 authorized \$182,500 payable out of the State General Fund (Direct) to the St. Tammany Parish Council (“Council”) for six separate purposes.

WHEREAS, the author of the line item appropriation intended St. Tammany Parish Government (“Parish Government”) to be the fiscal agent for the funding due to its exemplary financial administration; and the author also named specific non-profit agencies intended as recipients of the appropriations.

WHEREAS, the State Treasurers Office is amenable to the Parish Government being the fiscal agent for the Act 122 funding as the Council proposes in this resolution.

WHEREAS, on behalf of the Council, Parish Government will administer the \$72,500 appropriation for the North Shore Harbor Events Center.

WHEREAS, on behalf of the Council, Parish Government will administer the \$20,000 appropriation for the St. Tammany Association for Retarded Citizens dba STARC for the care of developmental disability clients through the Florida Parish region.

WHEREAS, on behalf of the Council, Parish Government will administer the \$25,000 appropriation for the St. Tammany Humane Society in support of local humane efforts.

WHEREAS, on behalf of the Council, Parish Government will administer the \$25,000 appropriation for the St. Tammany Association for Retarded Citizens dba STARC in support of community activities to assist persons with severe disabilities.

WHEREAS, on behalf of the Council, Parish Government will administer the \$25,000 and \$15,000 appropriations for Kids of Our Lacombe dba KOOL for aid to the needy in the Bayou Lacombe area.

THE PARISH OF ST. TAMMANY HEREBY authorizes St. Tammany Parish Government to enter into Cooperative Endeavor Agreements with the State of Louisiana on its behalf for \$182,500 in appropriations from Act 122 of the Louisiana 2009 Regular Session of the Legislature.
