AN ORDINANCE ESTABLISHING A "NO THRU TRUCKS" ZONE ON BROOKTER STREET (8-V-108) WARD 8, DISTRICT 13.

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the parish; and

WHEREAS, St. Tammany Parish has experienced an increase in truck traffic, proceeding at unsafe speeds through the primarily residential neighborhood of Springhill Subdivision;

WHEREAS, the affected citizens have requested a no thru truck zone to remedy the situation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO THRU TRUCKS" ZONE is hereby established on Brookter Street (8-V-108), as indicated on the attached traffic plan by the Department of Engineering. WARD 8, DISTRICT 13.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION IV: This ordinance shall become effective fifteen (15) days after adoption.

The Department of Engineering recommends the installation of signage in District 13.

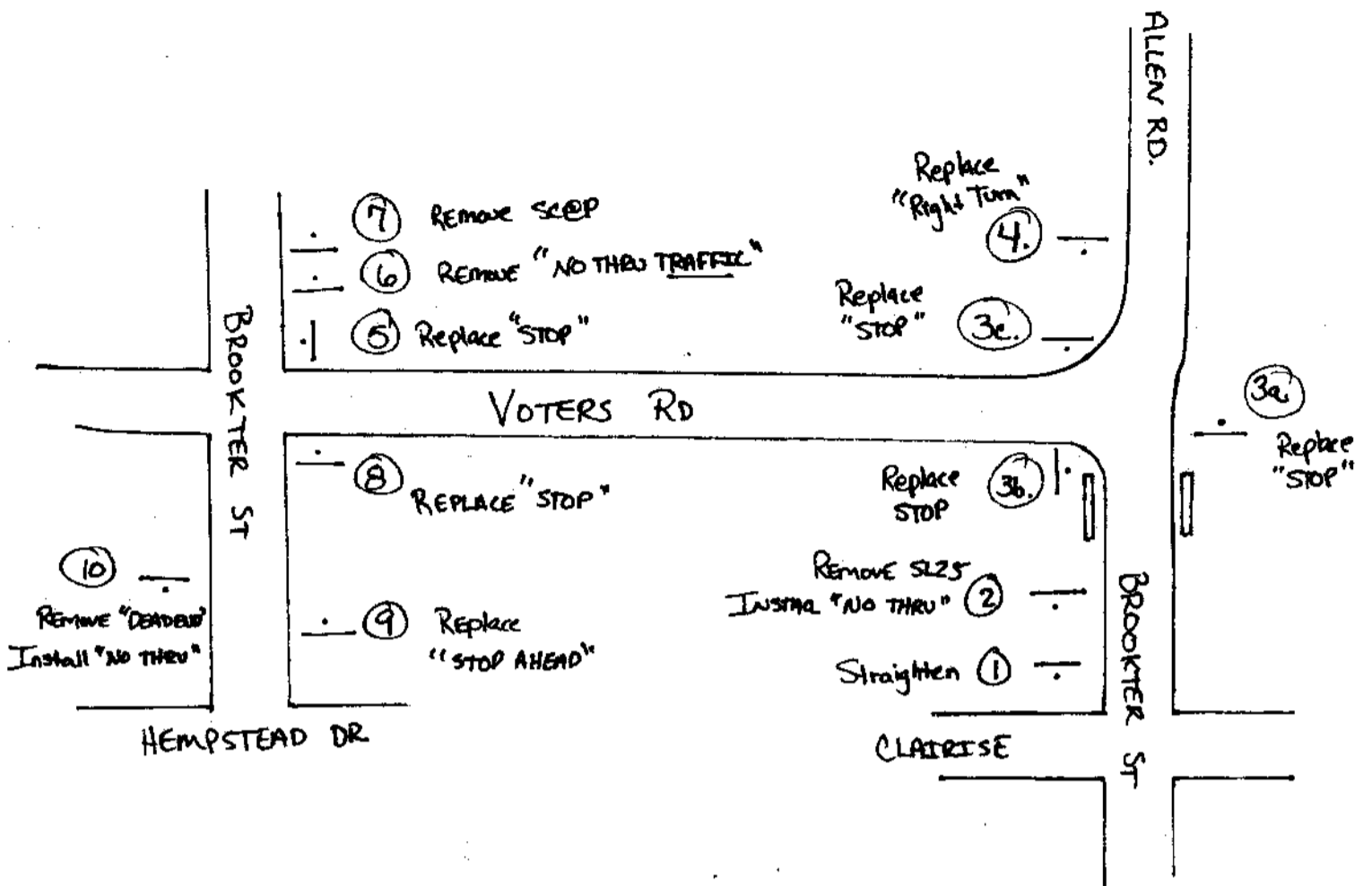
1. Straighten existing "Speed Limit 25" sign on Brookter.
  2. Replace other "Speed Limit 25" sign with a "No Trucks Thru" sign.
  3. (a. b. c.) Replace all 3 "STOP" signs at the intersection of Voters, Brookter, and Allen with new signs.
  4. Replace "Right Turn" sign with new sign
  5. Replace east facing "STOP" sign at the west intersection of Brookter and Voters.
  6. Remove "NO THRU TRAFFIC" sign on Brookter at the west intersection.
  7. Remove "SC@P" sign on Brookter at the west intersection.
  8. Replace south facing "STOP" sign at the west intersection of Brookter and Voters.
  9. Replace "Stop Ahead" sign and pole on Brookter near the west intersection of Brookter and Voters.

10. Remove "Dead End" sign on Brookter and install a "No Thru Trucks" sign.

Please install signs in accordance with MUTCD standards and see the attached sketch.
