ORDINANCE TO AUTHORIZE THE PARISH TO PROCEED WITH THE ADVERTISING AND POSTING OF LOT 51, SQUARE 233-A, RURAL MANDEVILLE, WHICH HAS BEEN DECLARED AS SURPLUS PROPERTY

WHEREAS, the Parish of St. Tammany owns property described as Lot 51, Square 233-A, Section 13, Township 7 South, Range 11 East, Mandeville said property having been adjudicated to the Parish for unpaid property taxes; and

WHEREAS, the Parish Council, through Resolution Council Series No. C-0562, adopted on July 12, 2002, has recommended that the property be declared surplus and no longer needed for public purposes; and

WHEREAS, Ordinance No. 09-2090 was adopted on July 2, 2009, which declared the said property to be surplus and authorized the Parish to proceed with the process for the sale, lease or disposal of said property; and

WHEREAS, the Parish Council desires to allow the advertisement of the Notice of Intention to Sell, and to post the property.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that the Office of the Parish President is authorized to proceed with the advertising and posting of this property necessary to carry out the intent of this Ordinance in a timely and orderly manner, in accordance with Parish Ordinances and State Statutes.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
