THE PARISH OF ST. TAMMANY HEREBY ORDAINS that the St. Tammany Parish Unified Development Code, Volume I, (Zoning) Section 5.31 ED-1 Primary Education District relative to Permitted Uses:

Add a new

<u>4.</u> Day Care, Nursery School, Pre-School, Kindergarten, and Karate/Dance/Gymnastics Schools limited with a total building size limited to 10,000 square feet in area.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
