AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE MADIE LANE, AND BIENVILLE ROAD LATERAL, ALSO TO DELETE CLEO ROAD. WARDS 2, 8 & 9, DISTRICTS 2, 6 & 11

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Madie Lane, located west off Mayers Trace, Ward 9, District 11;
2. Add Bienville Road Lateral # D02NW01006, located off Bienville Road, Ward 2, District 2; and
3. Delete Cleo Road (R08H-012), Ward 8, District 6; as this road has been annexed into the corporate limits of Town of Pearl River.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
