AN ORDINANCE ESTABLISHING A LOAD LIMIT 8 TONS AND NO THRU TRUCKS ZONE ON OAK HARBOR BOULEVARD FROM I-10, WEST TO HIGHWAY 11. (WARD 9, DISTRICT 12)

WHEREAS, the Parish Department of Public Works and Department of Engineering have reviewed the aforementioned roadway, and have subsequently determined to establish both a Load Limit 8 Tons Zone and a No Thru Trucks Zone on this road in the interest of public safety; and

WHEREAS, said zones established by this ordinance will not prohibit trucks from using this street if a truck is making a delivery to a site on Oak Harbor Blvd. or in a subdivision within the area of Oak Harbor that cannot be accessed by any other manner.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "LOAD LIMIT 8 TONS" and "NO THRU TRUCKS" Zone is hereby established on Oak Harbor Boulevard (R09J090) for the entire distance of said roadway from I-10, west to Hwy. 11.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at this location.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon final adoption.
