RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO EXECUTE COOPERATIVE ENDEAVOR AGREEMENT BY AND BETWEEN THE PARISH OF ST. TAMMANY AND GRAVITY DRAINAGE DISTRICT NO. 5.

WHEREAS, Improvements to the drainage infrastructure within Crestwood Subdivision will improve drainage within the subdivision and will also serve to reduce potential flooding in the surrounding area; and

WHEREAS, the Parish Department of Engineering has confirmed that the benefits resulting from improvements to the drainage infrastructure within Crestwood Subdivision will extend well beyond the boundaries of the Subdivision and in fact effect the entire geographical area; and

WHEREAS, the Parish Gravity Drainage District No. 5 and the Parish of St. Tammany desire to modify and improve the drainage system by increasing the size of the retention pond within the Crestwood Subdivision for the joint benefit of the Subdivision and the much larger geographical area surrounding same; and

WHEREAS, it is in the best interest of the public health, safety and welfare that the St. Tammany Parish enter into the proposed Cooperative Endeavor Agreement with the St. Tammany Parish Gravity Drainage District No. 5 in order to promptly address the drainage concerns associated with improving the drainage infrastructure within the Crestwood Subdivision that will serve to benefit the subdivision and the entire geographical area.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that for the purpose set forth herein above, it authorizes the Parish President to execute a Cooperative Endeavor Agreement By and Between St. Tammany Parish Gravity Drainage District No. 5 and the Parish of S Tammany.
