ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACCEPT THE ACT OF DEDICATION AND DONATION OF A PORTION OF RED ROOSTER ROAD FOR INCLUSION INTO THE ROAD MAINTENANCE SYSTEM. (WARD 8, DISTRICT 9)

WHEREAS,

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that:

SECTION I: Subject to petitioners' acceptance of the roadway standards set by the Parish Council and the Department of Engineering, the Act of Dedication and Donation of a portion of Red Rooster Road is accepted.

SECTION II: Said portion of Red Rooster Road shall be incorporated into the St. Tammany Parish Selective Road Maintenance System Inventory upon petitioners' completion of Parish roadway standards requirements and execution of the Act of Dedication by the parties.

SECTION III: The Parish President and/or C.A.O. is hereby authorized to execute any and all documents necessary in connection with said acceptance of Red Rooster Road.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

WHEREAS, following a public hearing held before the Planning Commission on November 9, 2011 (Rev11-10-094), the Planning Commission recommended that the current Red Rooster Road be revoked, subject to, and effective upon, the dedication and construction of the proposed Red Rooster Road, all as more particularly depicted on the attached drawing of J.V. Burkes & Associates, Inc., Drawing No. 20110231, dated 09/01/2011 (Exhibit 1); and

WHEREAS, after considering the recommendation of the St. Tammany Parish Planning Commission, the St. Tammany Parish Council has determined that it is in the best interest of the public health, safety and welfare to concur in the recommendation of the Planning Commission to revoke the current Red Rooster Road, a substandard road, subject to, and effective upon, the dedication and construction of the proposed Red Rooster Road.
