# RESOLUTION AMENDING RESOLUTION P.J.S. NO. 86-2675, WHICH GRANTED PERMISSION TO ENTER PARISH RIGHT-OF-WAY, SPECIFICALLY THE UNOPENED PORTION OF PONTCHARTRAIN BOULEVARD. (WARD 7, DISTRICT 7)

WHEREAS, on December 18, 1986, the St. Tammany Parish Police Jury adopted Resolution Police Jury Series No. 86-2675, granting permission to Eugene J. Joanen, III, 33 Mistletoe Drive, Covington, Louisiana 70433, to enter the Parish right-of-way, specifically Pontchartrain Boulevard (7-F-001), unopened portion, Ward 7, District 7, for the purpose of gaining access to property. Resolution P.J.S. 86-2675 and the following Exhibits thereto are attached hereto and incorporated herein by reference: (1) Plat of Land Surveyed for Mr. Eugene J. Joanen, III by Eddie J. Champagne, Registered Surveyor, Drawing No. 4116, November 24, 1977, depicting the unopened Pontchartrain Blvd. right-of-way; (2) A Survey of the Property of Eugene J. Joanen, III by H.C. Sanders & Associates, Civil Engineers & Land Surveyors, dated September 13, 1973; (3) Unidentified Area Map; and

WHEREAS, the expressed purpose for granting permission to enter the aforesaid right-of-way was to provide access to the property of Eugene J. Joanen, III. However, the Resolution specifically granted permission to then current owner, Eugene J. Joanen, III. Therefore, it is necessary to amend Resolution P.J.S. No. 86-2675 for the sole purpose of granting permission to Eugene J. Joanen, III and any subsequent owner of the property; and

WHEREAS, the permission granted by Resolution P. J. S. No. 86-2675 was made subject to the eight (8) conditions enumerated therein, which shall remain in full force and effect.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that Resolution P.J.S. No. 86-2675, adopted December 18, 1986, is hereby amended to grant permission to Eugene J. Joanen, III, and to his heirs, successors and assigns, to enter the Parish right-of-way, specifically the unopened portion of Pontchartrain Boulevard (7-F-001) depicted on the attached survey of Eddie J. Champagne, Surveyor, for the purpose of gaining access to the property of currently or formerly owned by Eugene J. Joanen, III, which property is depicted on the attached survey of H.C. Sanders & Associates.

BE IT FURTHER RESOLVED that, except as amended hereby, all other provisions, requirements and conditions of Resolution P.J.S. 86-2675 shall remain in full force and effect.




