ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO TRANSFER THE I-12/TCHEFUNCTE INTERCHANGE RIGHT-OF-WAY TO THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD).

WHEREAS, the St. Tammany Parish Government desires to transfer certain immovable property (hereinafter referred to as "Property"); and

WHEREAS, there is a need and a public purpose for the transfer of certain immovable property including rights of way and servitudes to LADOTD so that the I-12/Tchefuncte Interchange and its access points can be maintained by LADOTD; and

WHEREAS, the Parish of St. Tammany hereby desires to transfer the Property, rights of way and/or servitudes and authorizes the Office of the Parish President to do whatever is necessary to transfer said Property, servitudes and/or rights of way.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS to authorize the Parish of St. Tammany, to transfer all that certain parcel of ground described in Exhibit "A" attached hereto; and

That pursuant to all applicable provision of law, the Office of the Parish President is directed and authorized to do whatever is necessary to transfer the Property, servitudes and/or rights of way; and

That the Office of the Parish President is authorized and instructed to proceed with the transfer of the Property, servitudes and/or rights of way in a timely and orderly matter; and

That the Office of the Parish President is authorized to exercise its discretion in transferring the Property, servitudes and /or rights of way, together with all agreements and all transactions necessary to carry out the intent of this Ordinance; and

That, any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

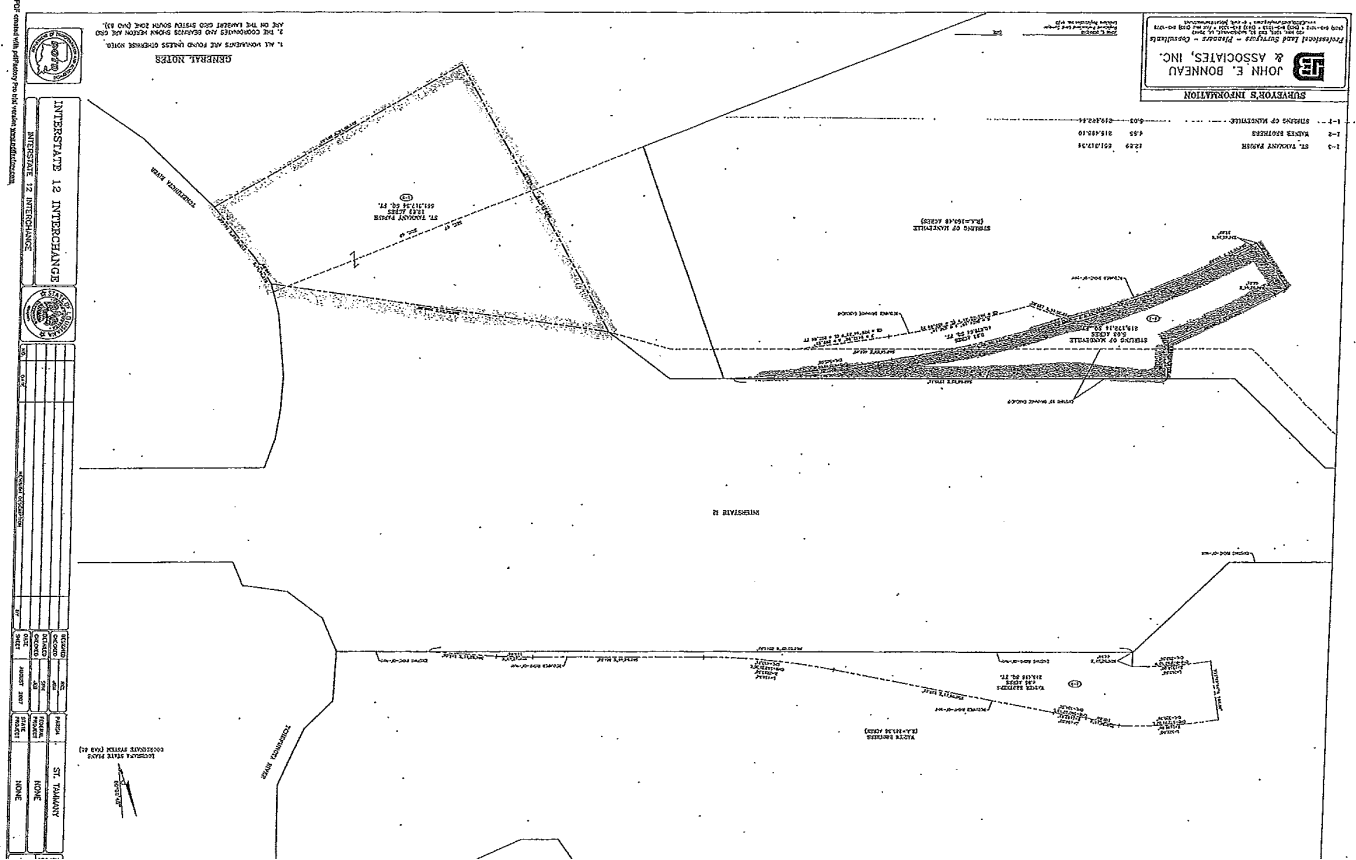
