RESOLUTION TO APPROVE AND AUTHORIZE ST. TAMMANY PARISH THROUGH THE OFFICE OF THE PARISH PRESIDENT TO SIGN AND/ OR EXECUTE COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE PARISH OF ST. TAMMANY AND CHRIST EPISCOPAL SCHOOL.

WHEREAS, Christ Episcopal School (hereafter "CES") is a school located on Christwood Blvd. in Covington, LA. Twice per weekday, parents and guardians of students were inadvertently causing traffic problems by blocking a travel lane on Christwood Blvd. while dropping off or picking up students. This blocking of traffic on Christwood Blvd. also caused a back up of traffic on LA Highway 21; and

WHEREAS, The Parish and CES recognized this as a significant safety hazard, not only to the parents and students, but the public in general; and

WHEREAS, CES has expended funds in the amount of \$ 15,228.00 (Fifteen Thousand Two Hundred Twenty-Eight dollars) for the purchase of gravel, dirt and labor costs to create a turn lane for approximately 600 (six hundred) feet which will provide vehicle stacking along side of and off of Christwood Blvd. thereby removing the back-up of vehicular traffic on Christwood Blvd.(hereinafter known collectively as the "Project"); and

WHEREAS, the Project has been constructed and payment has been issued by CES. Upon approval of the invoices the Parish seeks to reimburse CES fifteen thousand two hundred twenty eight dollars (\$ 15,228.00). Both the Parties desire to enter into a Cooperative Endeavor Agreement for the purpose of setting out each of the Party's duties and obligations in the furtherance of this Project.; and

WHEREAS, The Project was constructed on Parish right of way, which is the Parish's legal obligation to improve and maintain. The St. Tammany Parish Department of Public Works is able to and is legally obligated to provide its equipment, expertise and labor to provide for the maintenance of the Project.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish President is hereby authorized to sign and/ or execute a Cooperative Endeavor Agreement between St. Tammany Parish and Christ Episcopal School regarding the objectives stated above; and

THAT all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.
