ORDINANCE ESTABLISHING A SPEED LIMIT OF 20 MPH ON CERTAIN ROADS IN A PORTION OF THE GREENLEAVES PINES SUBDIVISION. (WARD 4,DISTRICT10)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the parish; and

WHEREAS, by nature of their narrow widths, volume of traffic and children, roads within the Greenleaves Pines Subdivision are unsafe at standard speed limits; and

WHEREAS, affected citizens have requested control measures be taken to address this unsafe situation on Parish roads.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS:

SECTION I: A speed limit of 20 mph is hereby established on the entirety of the following roads within the The Greenleaves Pines Subdivision. WARD 4, DISTRICT 10:

Ponderosa Pl. (4-D-125)

Loblolly Ct. (4-D-187)

Scotch Pine Ln. (4-D-188)

SECTION II: The Parish Department of Public Works is directed to replace all existing 25 MPH signs on these roads with 20 MPH signs.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective immediately upon final adoption.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This ordinance shall become effective immediately upon final adoption.
