AN ORDINANCE ESTABLISHING A NO THRU TRUCKS ZONE
ON SURGI DRIVE (4-E-90) (WARD 4, DISTRICT 5)

WHEREAS, St. Tammany Parish government is charged with protecting the safety and general welfare of citizens of the Parish, and

WHEREAS, St. Tammany Parish has experienced an increase in truck through traffic which is causing the roadway to deteriorate, and

WHEREAS, said zone established by this ordinance will not prohibit trucks from using this street if a truck is making a delivery to a site within the area.

THE PARISH OF ST. TAMMANY HEREBY ORDAIN:

SECTION I: A "no thru trucks" zone is hereby established on Surgi Drive (4-E-90), as indicated on the attached traffic plan by the Department of Engineering. Ward 4, District 5.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

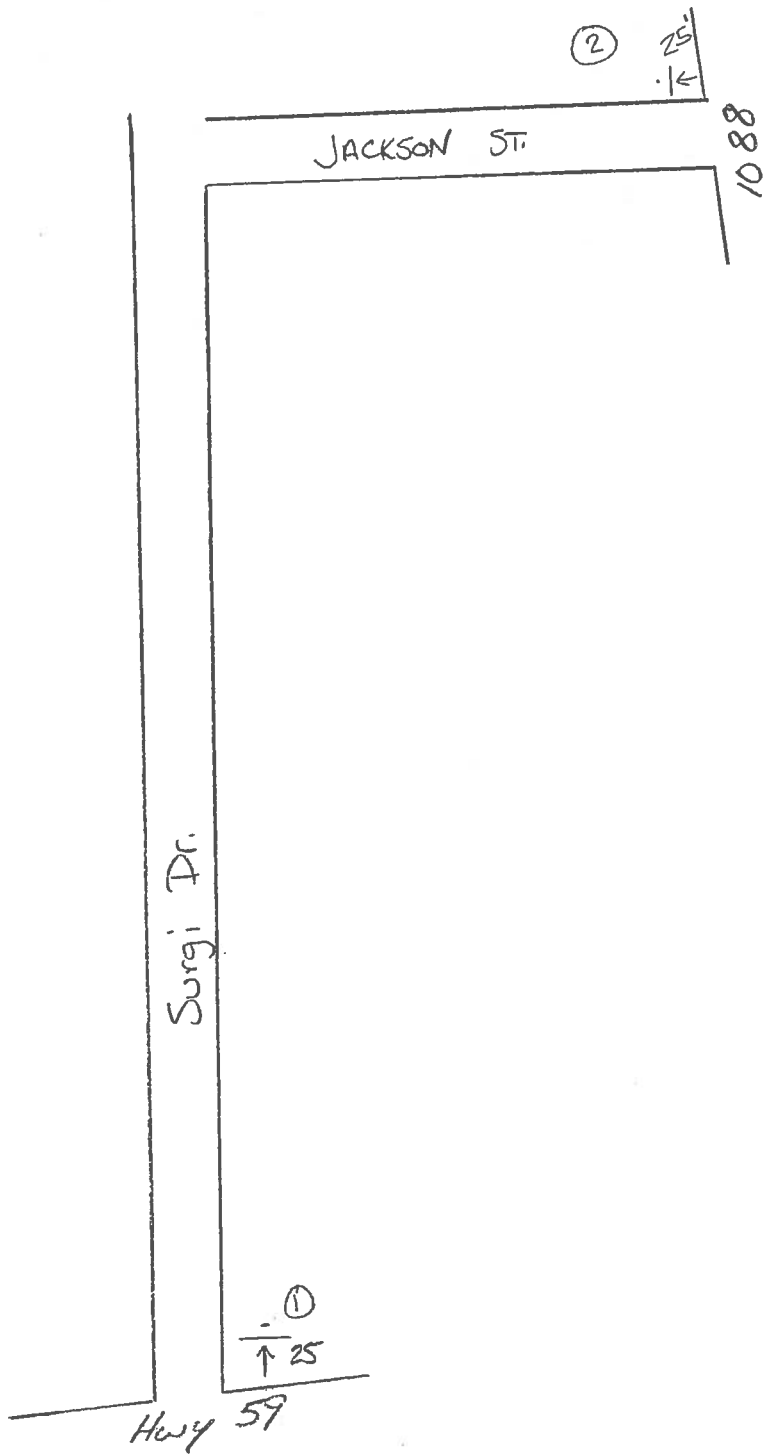
