RESOLUTION TO CERTIFY THAT THE ST. TAMMANY PARISH GOVERNMENT HAS NO BOND FUNDING SUFFICIENT TO FUND THE PROJECT ENTITLED *ST. TAMMANY PARISH FISHING PIER, PLANNING AND CONSTRUCTION.*

WHEREAS, St. Tammany Parish Government ("STPG") acquired a portion of the old Twin Span bridge from Louisiana Department of Transportation and Development for the purpose of constructing a public fishing pier; and

WHEREAS, the timber bridge and temporary facilities were constructed as Phase 1 and the St. Tammany Parish Fishing Pier officially opened on June 2, 2012; and

WHEREAS, STPG will use the proposed Capital Outlay funding to construct improvements at the St. Tammany Parish Fishing Pier; and

WHEREAS, STPG lacks any source of funds, inclusive of bond funding, sufficient to fund this project; and

WHEREAS, STPG has exhausted all other local options for funding this project, including taxation, special assessments, loans, bond issues and other sources; and

WHEREAS, STPG wishes to enter into a cooperative endeavor agreement with the State of Louisiana to avail itself of an opportunity to fund \$ 400,000 of this financial commitment in a letter of credit through the Capital Outlay Act of 2012; and

WHEREAS, under R.S. 39:101, the State of Louisiana requires that the STPG, the non-state entity requesting such funding, shall certify by resolution that it has no other funding for this project.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that it has exhausted all local options for funding this project, including taxation, special assessments, loans, bond issues and other sources and hereby requests funding for the above referenced project through the provisions of the Capital Outlay Act of 2012.
