# COMPREHENSIVE PLAN:

Industrial - The processing, packaging, delivery or production of goods or services, allowed at various types of and levels of activity. Such activities may include governmental, research, archival or medical.

#### **STAFF COMMENTS:**

The petitioner is requesting to change the zoning from A-1 (Suburban District) to HC-1 (Highway Commercial District). The site is located on the west side of LA Highway 59, north of Casril Drive, south of Parker Drive. The 2025 future land use plan designates the site to be developed with industrial uses. The site is currently vacant and directly abutting commercial and industrial uses on the north and south sides. Staff does not have any objection to the request, considering that the rezoning of the site to HC-1 would create a transition between the abutting commercial and industrial uses on the north and east sides, and the residential uses on the south and west sides.

Note that before the comprehensive rezoning, the property was zoned M-1 (Light Industrial) Zoning (ZC0-01-001).

#### STAFF RECOMMENDATION:

The staff recommends that the request for a HC-1 (Highway Commercial District) designation be approved.
