RESOLUTION APPROVING THE HOLDING OF AN ELECTION IN RECREATION DISTRICT NO. 6, ST. TAMMANY PARISH, LOUISIANA, ON SATURDAY, APRIL 21, 2012, TO AUTHORIZE THE LEVY OF A SPECIAL TAX THEREIN.

WHEREAS, the Board of Commissioners of Recreation District No. 6, St. Tammany Parish, Louisiana (the "Governing Authority"), acting as the governing authority of Recreation District No. 6, St. Tammany Parish, Louisiana (the "District"), adopted a resolution on January 19, 2012, calling a special election in the District on Saturday, April 21, 2012, to authorize the levy of a special tax therein; and

WHEREAS, the governing authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of St. Tammany, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to levy and collect the special tax provided for therein; and

WHEREAS, in accordance with Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and, in the event that the election carries, to further approve the levy and collection of the special tax provided for therein;

THE PARISH OF ST. TAMMANY HEREBY RESOLVES:

SECTION 1. In accordance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of Recreation District No. 6, St. Tammany Parish, Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, April 21, 2012, at which election there will be submitted the following proposition, to-wit:

PROPOSITION  
(MILLAGE)

Summary: 10 year, 6 mills property tax for acquiring, constructing, improving, maintaining, operating and/or supporting parks, playgrounds, recreation centers and other recreational facilities in Recreation District No. 6, together with the necessary furnishing, equipment and programs therefor.

Shall Recreation District No. 6, St. Tammany Parish, Louisiana (the "District"), levy a special tax of six (6) mills on all property subject to taxation in the District (an estimated \$117,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning with the year 2012 and ending with the year 2021, for the purpose of acquiring, constructing, improving, maintaining, operating and/or supporting parks, playgrounds, recreation centers and other recreational facilities in the District, together with the necessary furnishings, equipment and programs therefor?

SECTION 2. In the event the election carries, this Parish Council does hereby further consent to and authorize the District to levy and collect the special tax provided for therein.
