RESOLUTION TO DECLARE MOVABLE PROPERTY AS SURPLUS AND TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, AND THE LOUISIANA LOCAL SERVICES LAW, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT WITH THE TOWN OF PEARL RIVER FOR THE PRIVATE SALE AND DISPOSITION OF SAID PROPERTY (WARD 8, DISTRICT 9 & 14).

WHEREAS, from time to time, St. Tammany Parish Government may declare movable property as surplus, and no longer needed for a public purpose, as may be in the best interest of the Parish and its citizens; and

WHEREAS, St. Tammany Parish Government owns certain movable property more fully identified as a 1998 New Holland Boom Mower Tractor, Model 6640, VIN 086487B; and

WHEREAS, the Parish no longer has any use for the aforementioned property and now desires to declare said property as surplus and to sell and/or dispose of the same to the Town of Pearl River, Louisiana, at a price commensurate with its value; and

WHEREAS, the sale and/or disposition of said property to the Town of Pearl River will be in the best interest of the Parish and will benefit the Town of Pearl River, which will utilize said property for the benefit of its citizens and the general public; and

WHEREAS, the property will be sold by private sale, in accordance with the provisions of Louisiana Revised Statutes 33:1321, *et seq.*, and/or other applicable local and state legal authority.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that certain Parish property identified as a 1998 New Holland Boom Mower Tractor, Model 6640, VIN 086487B, is declared to be surplus property authorized to be sold and disposed of by private sale and/or other method of disposal.

BE IT FURTHER RESOLVED that pursuant to all applicable provisions of law, the Office of the Parish President is directed and authorized to assess, deem, designate and determine that said property is surplus.

BE IT FURTHER RESOLVED that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-03, 1-06, 3-01 and 3-09, and the Louisiana Local Services Law, is authorized to execute an Intergovernmental Agreement, which meets or exceeds all requirements of Louisiana law and jurisprudence, with the Town of Pearl River, Louisiana, for the sale and/or disposal of said property, and to execute all other agreements and transactions necessary to carry out the intent of this Resolution.

BE IT FURTHER RESOLVED that any and all actions previously taken by the Office of the Parish President in furtherance of actions contemplated herein are ratified and accepted accordingly.

Resolution Administrative Comment

RESOLUTION TO DECLARE MOVABLE PROPERTY AS SURPLUS AND TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, AND THE LOUISIANA LOCAL SERVICES LAW, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT WITH THE TOWN OF PEARL RIVER FOR THE PRIVATE SALE AND/OR DISPOSITION OF SAID PROPERTY (WARD 8, DISTRICT 9 & 14).

The Parish seeks to declare certain movable property surplus and authorize the sale of said property at a price commensurate with its value. The Parish is not currently using said property, and now seeks to enter into an Intergovernmental Agreement and/or other agreement for the sale and/or disposition of the same to the Town of Pearl River, Louisiana, which will use said property for the benefit of its citizens. The Louisiana Local Services Law, as codified in Louisiana Revised Statutes § 33:1321, *et seq.*, further authorizes the objectives sought through this Resolution.
