St. Tammany Parish seeks to acquire certain parcels, rights of way and/or servitudes through the Hazard Mitigation Grant Program. Funding for this acquisition comes from the Hazard Mitigation Grant Program administered by the Governor's Office of Homeland Security and Emergency Preparedness. The attached legal description depicts all parcels to be acquired. The Parish intends to pay no more than appraised value or less, plus closing costs and fees for any acquired property.
