RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 3-01 AND 3-09, FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO SIGN AND/OR EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE OAK HARBOR PROPERTY OWNERS ASSOCIATION FOR SIGN MAINTENANCE (WARD 9, DISTRICT 12).

WHEREAS, Oak Harbor Property Owners Association, Inc. owned, operated and maintained a subdivision monument sign situated in the median of Oak Harbor Boulevard near its intersection with Highway 11; and

WHEREAS, as part of the Louisiana Department of Transportation and Development's construction along Highway 11, the then-existing subdivision sign was demolished; and

WHEREAS, with the completion of the Highway 11 improvements, Parish has agreed to construct a monument sign in Parish's right-of-way and Oak Harbor Property Owners Association, Inc. has agreed to maintain the sign once constructed, along with any appurtenant irrigation.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 3-01, and 3-09, is hereby authorized to sign and/or execute a Cooperative Endeavor Agreement with Oak Harbor Property Owner's Association, Inc. which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the future maintenance of a monument sign and appurtenant irrigation to be constructed on the Oak Harbor Boulevard median and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions authorized herein.

## **Administrative Comment**

RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 3-01 AND 3-09, FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO SIGN AND/OR EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE OAK HARBOR PROPERTY OWNERS ASSOCIATION FOR SIGN MAINTENANCE (WARD 9, DISTRICT 12).

Oak Harbor HOA's then-existing subdivision sign was demolished so that improvements could be made to Highway 11. Now that LaDOTD has completed that construction, Parish will replace their sign in Parish right-of-way. This agreement will obligate the HOA to maintain all aspects of the new sign following its construction along with any appurtenant irrigation.
