ORDINANCE TO PROHIBIT THE ISSUANCE OF ANY DRIVEWAY PERMITS GRANTING PERMISSION TO ACCESS STONEBRIDGE DRIVE LOCATED IN ST. TAMMANY PARISH COUNCIL DISTRICT 8.

WHEREAS, to protect and preserve the health, safety and welfare of residents from the adverse effects of traffic within a certain portion of unincorporated Ward 8, Council District 8 of St. Tammany Parish, it is necessary to prohibit the further issuance of driveway permits which grant access to the one way street known as Stonebridge Drive.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it prohibits the issuance of driveway permits granting permission to access Stonebridge Drive within a portion of Ward 8, Council District 8.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
