St. Tammany Parish seeks to acquire 45.391 acres comprising "Cardinal Cove", including improvements, on the Safe Haven Campus from Pelican Park/St. Tammany Parish Recreation District No. 1. Cardinal Cove was previously sold to Pelican Park as part of 100.387 acres.
