AN ORDINANCE TO OFFICIALLY CHANGE THE NAME OF A PARISH RIGHT OF WAY FROM ROGER EXTENSION DRIVE TO DENTY CRAWFORD ROAD AS SHOWN ON THE ATTACHED PLANS.

WHEREAS, a petition has been submitted to the Department of Planning & Development and forwarded to the Parish 911 Communications District signed by at least 50 percent plus one of the property owners owning or fronting the parish right of way has been submitted; and

WHEREAS, the St. Tammany Parish 911 Communications District has received, reviewed and approved the Road Name Request Form for the Parish Right of Way. Pending Approved Name: Denty Crawford Road, Nearest Cross-street: Troy Drive, Slidell, LA 70458. Since future structures will be addressed off the Parish Right of Way, the road will be added to the 911 Database and to the 911 Dispatch Map.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government officially change the name of the Parish Right of Way from Roger Extension Drive to Denty Crawford Road as shown on the attached plan.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

Dear Ms. Lambert:

I, Denty Crawford, request to change the name of Roger Drive Extension to Denty Crawford Road. I am the only resident that fronts this road, which was a right of way left by developer John Dunbar. I have paid for all costs and expenses, from beginning to end, for the construction of this road. Expenses that includes an \$8,000.00 performance obligation, \$4,600 warranty obligation, insurance on the property, and all permits. Corps of Engineers soil bore samplers, surveying several times by JV Burkes, which also included the design and drawing of plans for a black top road that were in accordance with St. Tammany Parish specifications, which I personally submitted to the parish for approval. I hired Lowe Bros., L.L.C. to clear the right of way and then construct and build this road to previous mention specifications. I was on this site daily, from the beginning of this project to the final inspection. I personally planted grass on the shoulders, and kept and still keep the entire area clear of any debris, which included picking up trash and garbage that irresponsible citizens would dump in the area because this road dead ends.

I have spent an enormous amount of my personal time and money on this road project. I have attached my property tax bill to show taxes paid.

With all of the above said, I wish to name this new road, DENTY CRAWFORD ROAD.

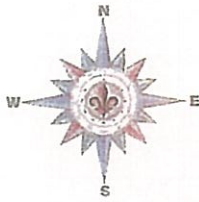

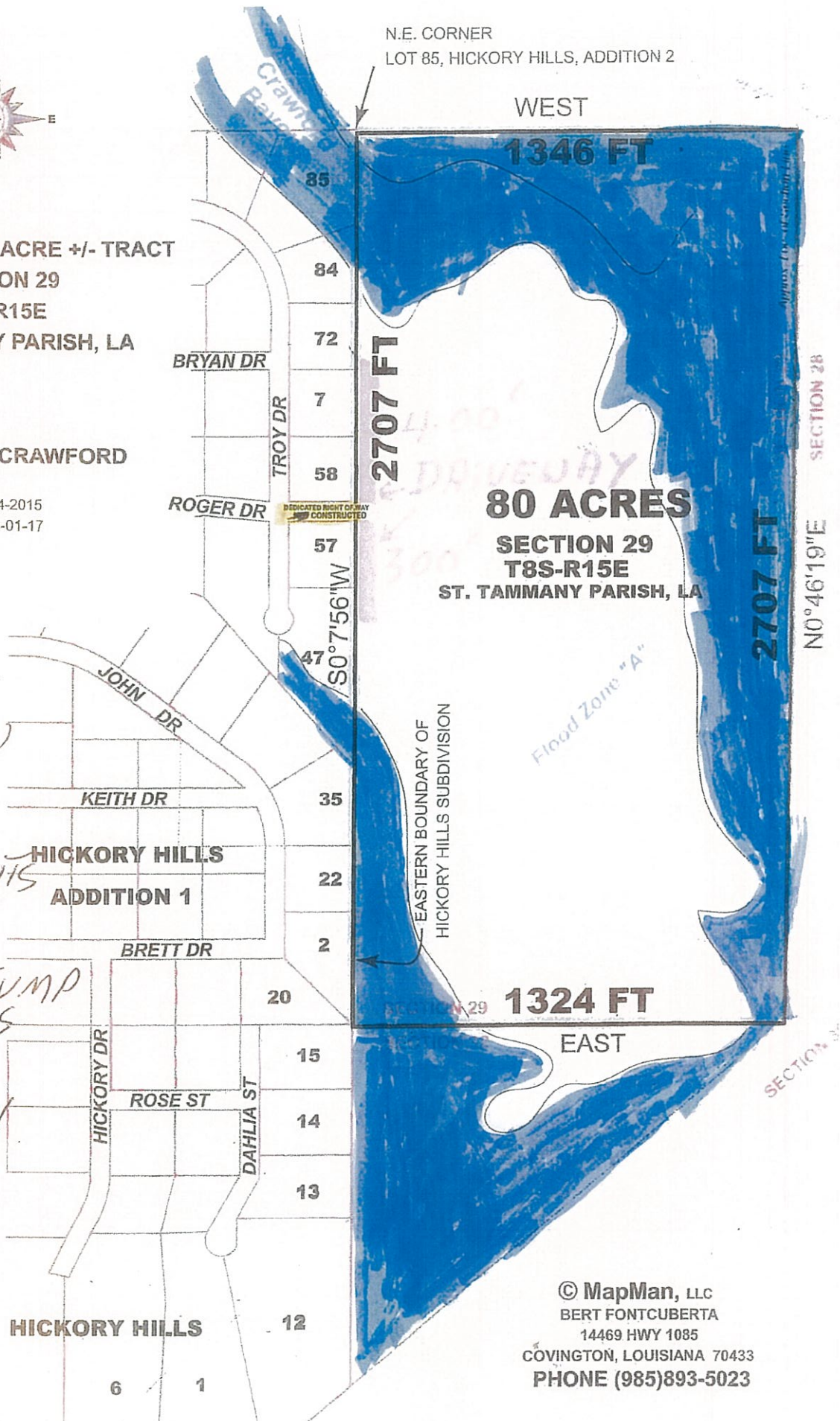
