Safe Haven Training/Education Center      Allocate additional funds based on the cost estimate for construction of the Safe Haven Training and Education Center. The total project budget is \$893,000 with \$500,000 funded by a capital outlay grant, \$240,000 funded by Public Health ad valorem tax, and \$153,000 funded by Deep Water Horizon funds.
