AN ORDINANCE TO TEMPORARILY SUSPEND CERTAIN PROVISIONS OF ORDINANCE NO. 12-2663, REGARDING THE USE OF MAJOR LANE.

WHEREAS, Ordinance No. 12-2663 revoked a portion of the cul-de-sac at the end of Major Lane, which is a Parish road; required the owner/developer of Lake Ramsey Estates, Phase 4-A, to install a gate and an aggregate surface area at the dead end of Major Lane; and allowed public use of the intersection only in the event that it was necessary for emergency purposes; and

WHEREAS, "Emergency Purposes" is defined in the ordinance as including "ingress and/or egress by first responders and evacuations in case of natural disaster;" and

WHEREAS, "First responders" are limited to law enforcement, fire services, emergency medical services, and emergency management officials; and

WHEREAS, the front entrance of Lake Ramsey subdivision, which is currently the only manner of ingress and egress for the Subdivision, has been structurally compromised such that its use by heavy construction vehicles, such as dump trucks and concrete trucks, could further damage the front entrance; and

WHEREAS, a building permit has been issued by St. Tammany Parish Government to build a residence in Lake Ramsey Subdivision.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the use limitation ordained by Ordinance No. 12-2663 is temporarily suspended only insofar as to allow construction vehicles, which are conducting work pursuant to a permit granted by St. Tammany Parish Government and for no other purpose, to use the Major Lane emergency entrance/exit either during the pendency of the repairs being conducted at the front entrance of Lake Ramsey Subdivision or six (6) months, whichever is sooner.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
