| Tchefuncte Habitat Restoration | Allocate available funds to construct a breakwater and bulkhead. Project will include rip rap to protect the shoreline surrounding the historic Tchefuncte River Lighthouse, and construction of a pier to create access to the lighthouse. This project will prevent further erosion to wetland habitat for the Town of Madisonville and the Lake Pontchartrain Basin. Work completed will be donated to those entities when complete. |
| Lock No.1 Boat Launch Restoration | Allocate available funds for the restoration of the boat ramp area at the Pearl River Diversion Canal Lock No.1. Project will include boat ramps, roads, and a parking area, and will provide coastal protection, conservation, hurricane protection, and infrastructure which were directly affected by coastal wetland losses. |
