RESOLUTION TO AUTHORIZE THE TEMPORARY CHANGE OF POLLING PLACES FOR TWO PRECINCTS.

WHEREAS, Proclamation No. 25 JBE was signed by Governor John Bel Edwards on March 11, 2020, declaring a statewide public health emergency as a result of the imminent threat posed to Louisiana citizens by COVID-19; and

WHEREAS, the established polling place for Precinct 115 is Avanti Senior Living located at 2234 Watercross Pkwy, Covington, La and the established polling places for Precinct 417 is Lakeview Regional Medical Center located at 95 Judge Tanner Blvd, Covington, La; which have a conflict due to the current public health emergency situation; and

WHEREAS, Holy Trinity Lutheran Church located at 1 N. Marigold Dr, Covington, La is currently the polling place for Precincts 103, 110, and 113 and will be also used as a temporary polling place for Precinct 115 effective for the November 3, 2020 Presidential General and Open Congressional Primary Election and the December 5, 2020 Open General/Congressional/Republican State Central Committee Election; and

WHEREAS, Northshore Pastoral Center of the Archdiocese of New Orleans located at 4465 Hwy190 E. Service Road, Covington, La is currently the polling place for Precincts 418 and 429 and will also be used as a temporary polling place for Precinct 417 effective for the November 3, 2020 Presidential General and Open Congressional Primary Election and the December 5, 2020 Open General/Congressional/Republican State Central Committee Election.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish Council authorizes the temporary change of Polling Place for voting Precinct 115 from Avanti Senior Living to Holy Trinity Lutheran Church and for Precinct 417 from Lakeview Regional Medical Center to Northshore Pastoral Center of the Archdiocese of New Orleans effective for the November 3, 2020 Presidential General and Open Congressional Primary Election and the December 5, 2020 Open General/Congressional/Republican State Central Committee Election.
