WHEREAS, the St. Tammany Parish 911 Communications District has received, reviewed and approved the Road Name Request Form for the unnamed private road. Pending Approved Name: Romans Road, Nearest Cross-street: Louisiana Highway 1081, Covington, LA 70435. Since future structures will be addressed off the newly name private road; the private road will be added to the 911 Database and to the 911 Dispatch Map;

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government officially name the private road shown on the attached drawing and survey as Romans Road.
