Administrative Comment Amendment No. 14 - 2020 Operating Budget - March 2021

This budget amendment is to:

a. 300 - DEBT - SALES TAX DISTRICT NO. 3

To amend the budget to increase funding sources for the Series 2020 Sales Tax Refunding Bond issuance and to increase expenditures and funding uses for the debt service and issuance costs, with the remaining funds of approximately \$22.9 million used to refund the Series 2013 Bonds outstanding for fiscal years 2025-2031.

b. **303 - DEBT - GOMESA**

To amend the budget to increase funding sources for the Series 2020 Revenue Bond issuance and to increase funding uses for the issuance costs and the transfer of approximately \$21.2 million to Capital Projects Fund 203. Capital projects will be identified and presented on future Capital Ordinances.
