ORDINANCE TO AMEND THE PARISH CODE OF ORDINANCES, CHAPTER 28, ARTICLE III WATERWAYS, DIVISION II WATERCRAFT SPEED LIMITS, SECTION 28-121 (A) (5) TO CREATE AN ADDITIONAL DEAD SLOW, NO WAKE ZONE ON A PORTION OF BAYOU LACOMBE (WARD 7, DISTRICT 7)

WHEREAS, in the interest of public safety, health and general welfare, it is necessary to create an additional "Dead Slow, No Wake" zone for a portion of Bayou Lacombe commencing approximately 1300 feet downstream from the Highway 190 Bridge and ending approximately 1800 feet downstream from the Highway 190 Bridge as indicated on the attached map.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it amends Parish Code of Ordinances, Chapter 28, Article III Waterways, Division 2 Watercraft Speed Limits, Section 28-121(a)(5) Operation; special speed limits; definitions, Unlawful operation, Bayou Lacombe area to create an additional "Dead Slow, No Wake" zone on a portion of Bayou Lacombe, amended to be read as follows:

g. <u>A portion of Bayou Lacombe commencing approximately 1300 feet downstream from the Highway 190 Bridge and ending approximately 1800 feet downstream from the Highway 190 Bridge as indicated on the attached map.</u>

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
