AN ORDINANCE TO AMEND THE PARISH CODE OF ORDINANCES, CHAPTER 105 BUILDINGS AND CONSTRUCTION, ARTICLE IX MUNICIPAL ADDRESSING, SECTION 767 TO AMEND CERTAIN REQUIREMENTS FOR MUNICIPAL ADDRESSING.

WHEREAS, Section 105-767 of the Parish Code of Ordinances currently requires that the "parish governing authority", being the Parish Council, approve municipal addresses.

WHEREAS, providing for the St. Tammany Parish Communication District No. 1 (911) approval, rather than Council approval, would streamline the addressing process which is in the interest of public health, safety, and welfare.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Parish Code of Ordinances Section 105-767 be amended as follows:

It is hereby required that each and every property holder identify the physical location of any and all residential, commercial and industrial structures by obtaining a municipal address for each such structure from the ~~parish governing authority~~ St. Tammany Parish Communication District No. 1. Thereafter, it is the responsibility of each property holder to purchase and affix numbers in a visible location on every residential, commercial or industrial building belonging to him.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
