Fritchie Marsh-Salt Bayou	Allocate available funds for marsh creation in an area identified as critical in the Coastal Protection and Restoration Authority (CPRA) Coastal Master Plan. This project will identify the optimal marsh site within Fritchie Marsh near Salt Bayou, identify a suitable borrow source from Lake Pntchartrain, and then develop a full engineering, design, and permitting package suitable for project construction. Project budget is \$1,200,000 with \$800,000 from GOMESA and \$400,000 from CPRA.
Slidell Breakwater Restoration	Reduce available funds and reallocate to the Fritchie Marsh-Salt Bayou project.
