RESOLUTION TO AUTHORIZE THE TEMPORARY CHANGE OF POLLING PLACES FOR PRECINCTS 103, 110, 113, 115, AND 417.

WHEREAS, Avanti Senior Living located at 2234 Watercross Pkwy, Covington, LA is the established polling place for Precinct 115 and Lakeview Regional Medical Center located at 95 Judge Tanner Blvd, Covington, LA is the established polling place for Precinct 417; both of which have a conflict due to the current public health emergency; and

WHEREAS, Holy Trinity Lutheran Church located at 1 N. Marigold Dr. Covington, LA is currently the polling place for Precincts 103, 110, and 113 and was used as the temporary polling place for Precinct 115, and which is unavailable for use due to the current public health emergency; and

WHEREAS, Northshore Pastoral Center of the Archdiocese of New Orleans located at 4465 Hwy 190 E. Service Road, Covington, LA is currently the polling place for Precincts 418 and 429 and has also been used as a temporary polling place for Precinct 417 effective for the November 3, 2020 election; and

WHEREAS, Coquille Recreation District located at 13505 LA-1085, Covington, LA has been used as a temporary polling place for Precincts 103, 110, and 113.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish Council authorizes the temporary change of polling place for voting Precinct 115 from Avanti Senior Living to Coquille Recreation District; for voting Precincts 103, 110, and 113 from Holy Trinity Lutheran Church to Coquille Recreation District; and for Precinct 417 from Lakeview Regional Medical Center to Northshore Pastoral Center of the Archdiocese of New Orleans effective for the October 9, 2021 and November 13, 2021 elections.
