ORDINANCE TO AUTHORIZE ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE FULL OWNERSHIP INTEREST OF CERTAIN PROPERTIES ADJUDICATED TO ST. TAMMANY PARISH FOR RIGHT-OF-WAY AND/OR DRAINAGE MAINTENANCE AND/OR IMPROVEMENTS

WHEREAS, Parish has identified certain properties attached hereto as desirable to Parish for use in maintaining and/or improving Parish right-of-way and/or drainage features; and

WHEREAS, the requisite time has passed for the owners of the annexed properties to redeem their property, as per Louisiana Revised Statute 47:2122(11) and the Louisiana Constitution, Article 7, Section 25; and

WHEREAS, Parish seeks to initiate the process mandated by Louisiana Revised Statute 47:2236 to claim the properties annexed hereto in full ownership.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that pursuant to all applicable provisions of law and in particular Louisiana Revised Statute 47:2236, the Office of the Parish President is authorized to do whatever is necessary to acquire the properties annexed hereto; and

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
