# Administrative Comment Amendment No. 13 - 2021 Operating Budget - November 2021

This budget amendment is to:

#### a. 122 - ECONOMIC DEVELOPMENT FUND

To amend the budget to decrease revenues based on the rent abatement taken by the Children's Museum from April through December in regards to the Phase 3 status of COVID.

### b. 126 - ST. TAMMANY PARISH CORONER FUND

To amend the budget to increase expenditures. The Parish will transfer the fund balance in the Special Revenue Fund to the Coroner in accordance with the CEA to be executed per Council Ord. Cal. No. 6763, which is scheduled to be introduced at the October 7, 2021 Council Meeting. In accordance with Louisiana R.S. 13:5726, cash will be transferred when available based on collection of ad valorem taxes, for which some will not be received until Jan – March 2022.

To amend the budget to increase revenues based on actual collections.
