| Safe Haven ADA Handrails-Quads B & C | Allocate available funds to modify Quad B and C handrails to meet ADA requirements. |
| Safe Haven Awnings-Quads A & B | Allocate available funds to install three tube steel and corrugated metal roof awnings throughout Quads A and B. |
| Safe Haven Boiler House | Allocate available funds to clean, prep, and paint approximately 2,650 square feet of flooring and 1,890 square feet of walls in the Boiler House building. |
| Safe Haven Cooling Tower Valves | Allocate available funds to replace the bypass valves on the cooling tower for improved control systems and efficient operation. |
| Safe Haven Gutters-Quads A, B, C, & G | Allocate available funds to replace the rain gutters on the exterior of Quads A, B, C, and G. |
| Safe Haven HVAC Air Handlers-Quads B & C | Allocate available funds to route the HVAC air handlers to the emergency circuit in Quads B and C to allow for power connection during emergencies and outages. |
| Safe Haven HVAC Controls-Quad B | Allocate available funds to install/extend the building automation system HVAC controls to Quad B. |
| Safe Haven Riser Pipes | Allocate available funds to replace the insulation on the riser pipes for improved energy efficiency. |
