Water/Sewer Projects	Allocate funds to: (1) accept the recommendations of the Owen and White report, (2) construct needed, engineer-designed ground and elevated water storage facilities parish-wide, (3) address distressed systems as identified by LDH and LDEQ, and (4) perform other needed water and sewer projects parish-wide. This is to reserve some of the funds from the first allocation of ARPA funds of \$25,291,669.00. All projects must be qualified for funding use in accordance with all requirements of the American Rescue Plan Act of 2021. Funds may be used directly or as match to accomplish these projects. As specific projects are identified, they will be submitted individually for introduction and adoption.
