Grant award received to acquire a 16-passenger, 2 wheelchair space, rural transportation vehicle to be used by Council on Aging St. Tammany (COAST). Total funding for the vehicle includes \$126,717.44 from FTA (85%), \$4,174.22 from DOTD (2.8%), and \$20,187.68 from Parish Funds.
