ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACCEPT AN ACT OF DEDICATION AND DONATION OF WATER AND SEWER LINES AND ASSOCIATED SERVITUDES ALONG A PORTION OF PENNROSE STREET (WARD 4, DISTRICT 5)

WHEREAS, Peace Enterprises, LLC, Popham Properties, LLC and Bespoke Real Estate Investments, LLC (collectively, the "Owners") constructed and are the owners of certain water and sewer lines and associated infrastructure and utility servitudes along Pennrose Street and its intersection with Bay Street as shown on the plans attached hereto (the "Property"); and

WHEREAS, Owners have requested that St. Tammany Parish Government accept the dedication and donation of the Property in consideration of the use of the Property for delivery of water and sewer services; and

WHEREAS, there is a need and a public purpose for the acquisition of the Property for further enhancement and future expansion of Parish water/sewer infrastructure; and

WHEREAS, Parish hereby desires to acquire the Property by Act of Dedication and Donation for the use of the Property to provide water and sewer services.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: to authorize St. Tammany Parish Government, through the Office of the Parish President, to acquire by Act of Dedication and Donation all that certain property identified the water and sewer lines and related equipment plus utility servitudes necessary to said lines as shown on the attached Plans for Sewer and Water Extension for Lots 1A & 5A, Square 11, Montgomery Trace dated February 3, 2021 prepared by Deep South Design Group, a copy of which is attached hereto (the "Property"); and

BE IT FURTHER ORDAINED: that the Office of the Parish President is hereby authorized to exercise its discretion in acquiring the Property, together with signing all documents, agreements and transactions necessary to carry out the intent of this Ordinance; and

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

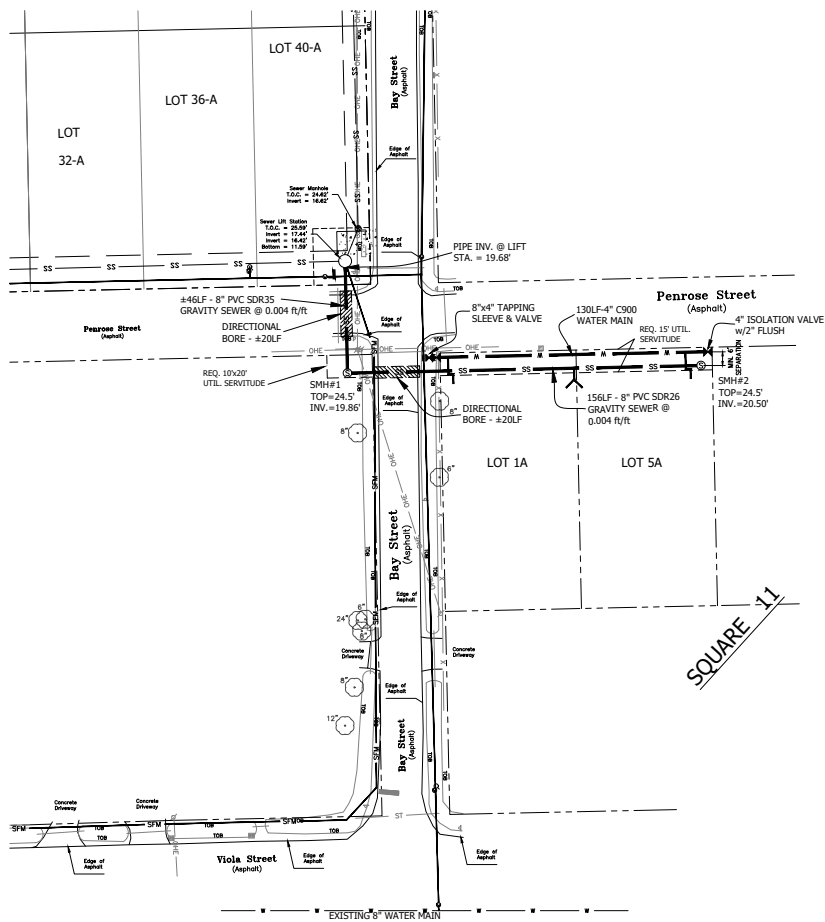
